2. WORK COMPLETED BY A GOVERNMENTAL SUBDIVISION OR STATE AGENCY COSTING LESS THAN \$15,000.00

PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.

## APPLICANT SIGNATURE

SECTION 23a OF THE STATE CONSTRUCTION CODE ACT OF 1972, 1972 PA 230, MCL 125.1523A, PROHIBITS A PERSON FROM CONSPIRING TO CIRCUMVENT THE LICENSING REQUIREMENTS OF THIS STATE RELATING TO PERSONS WHO ARE TO PERFORM WORK ON A RESIDENTIAL BUILDING OR A RESIDENTIAL STRUCTURE. ## VII. FEE CLARIFICATIONS

ITEM#21, MOBILE HOME UNIT SITE: WHEN INSTALLING A SITE SERVICE IN A PARK, THE PERMIT APPLICATION MUST INCLUDE THE APPLICATION FEE, SERVICE, PLUS THE NUMBER OF SITES AND THE NUMBER OF INSPECTIONS. WHEN SETTING A HUD MOBILE IN A PARK, A PERMIT MUST INCLUDE THE APPLICATION FEE, FEEDER AND AN INSPECTION. THIS SHALL BE DONE BY A LICENSED ELECTRICAL CONTRACTOR. WHEN SETTING A HUD OR PREMANUFACTURED HOME ON PRIVATE PROPERTY, A PERMIT MUST INCLUDE THE APPLICATION FEE, SERVICE FEEDERS, ANY ADDITIONAL WORK AND INSPECTIONS.

**IX. INSTRUCTIONS FOR COMPLETING APPLICATION**

GENERAL: ELECTRICAL WORK SHALL NOT BE STARTED UNTIL THE APPLICATION FOR PERMIT HAS BEEN FILED WITH THE OTSEGO COUNTY BUILDING DEPARTMENT. ALL INSTALLATIONS SHALL BE IN CONFORMANCE WITH THE STATE ELECTRICAL CODE. **NO WORK SHALL BE CONCEALED UNTIL IT HAS BEEN INSPECTED.**

THE TELEPHONE NUMBER FOR THE OFFICE HAS BEEN PROVIDED ON THE PERMIT FORM. WHEN READY FOR AN INSPECTION, CALL THE OFFICE, PROVIDING AS MUCH NOTICE AS POSSIBLE.(MINIMUM 24 HOUR-MAXIMUM 7 DAYS). YOU WILL NEED TO SUPPLY THE BUILDING AND/OR ELECTRICAL PERMIT NUMBER TO SET UP THE INSPECTION.

EXPIRATION OF PERMIT: A PERMIT REMAINS VALID AS LONG AS WORK IS PROGRESSING AND INSPECTIONS ARE REQUESTED AND CONDUCTED. A PERMIT SHALL BECOME INVALID IF THE AUTHORIZED WORK IS NOT COMMENCED WITHIN SIX MONTHS AFTER ISSUANCE OF THE PERMIT OR IF THE AUTHORIZED WORK IS SUSPENDED OR ABANDONED FOR A PERIOD OF SIX MONTHS AFTER THE TIME OF COMMENCING WORK. **A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

WHERE TO SUBMIT APPLICATION: THE OTSEGO COUNTY BUILDING DEPARTMENT IS RESPONSIBLE FOR ALL INSPECTIONS EXCEPT THOSE IN STATE OWNED BUILDINGS AND SCHOOLS. IF YOU HAVE ANY QUESTIONS REGARDING WHETHER TO SEE OUR OFFICE OR THE STATE FOR PERMITS AND INSPECTIONS, PLEASE CONTACT OUR OFFICE. THE INSPECTORS CAN BE REACHED AT THE NUMBER ON THE FRONT OF THIS APPLICATION BETWEEN 8 A.M. AND 9 A.M. FOR CODE RELATED QUESTIONS.
