VIIA. FEE CLARIFICATIONS

ITEM#2, MOBILE HOME UNIT SITE: WHEN ITEM IS USED FOR A SEWER EXCAVATIONS IN A NEW PARK, THE PERMIT APPLICATION SHOULD INCLUDE THE APPLICATION FEE PLUS THE NUMBER OF UNIT SITES. WHEN SETTING A MOBILE HOME IN A PARK, OR A MOBILE OR MODULAR HOME ON PRIVATE PROPERTY, A PERMIT SHOULD INCLUDE THE APPLICATION FEE, A SEWER OR BUILDING DRAIN, AND A WATER DISTRIBUTION SERVICE OR WATER DISTRIBUTION PIPE.

IX. INSTRUCTIONS FOR COMPLETING APPLICATION

GENERAL: PLUMBING WORK SHALL NOT BE STARTED UNTIL THE APPLICATION FOR PERMIT HAS BEEN FILED WITH THE OTSEGO COUNTY BUILDING DEPARTMENT. ALL INSTALLATIONS SHALL BE IN CONFORMANCE WITH THE STATE PLUMBING CODE. **NO WORK SHALL BE CONCEALED UNTIL IT HAS BEEN INSPECTED.**

THE TELEPHONE NUMBER FOR THE INSPECTOR HAS BEEN PROVIDED ON THE PERMIT FORM. WHEN READY FOR AN INSPECTION, CALL THE OFFICE, PROVIDING AS MUCH NOTICE AS POSSIBLE.(MINIMUM 24 HOUR-MAXIMUM 7 DAYS). YOU WILL NEED TO SUPPLY THE BUILDING AND/OR PLUMBING PERMIT NUMBER TO SET UP THE INSPECTION.

EXPIRATION OF PERMIT: A PERMIT REMAINS VALID AS LONG AS WORK IS PROGRESSING AND INSPECTIONS ARE REQUESTED AND CONDUCTED. A PERMIT SHALL BECOME INVALID IF THE AUTHORIZED WORK IS NOT COMMENCED WITHIN SIX MONTHS AFTER ISSUANCE OF THE PERMIT OR IF THE AUTHORIZED WORK IS SUSPENDED OR ABANDONED FOR A PERIOD OF SIX MONTHS AFTER THE TIME OF COMMENCING WORK. **A PERMIT WILL BE CANCELED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

WHERE TO SUBMIT APPLICATION: THE OTSEGO COUNTY BUILDING DEPARTMENT IS RESPONSIBLE FOR ALL INSPECTIONS EXCEPT THOSE IN STATE OWNED BUILDINGS AND SCHOOLS. IF YOU HAVE ANY QUESTIONS REGARDING JURISDICTION, SEE OUR OFFICE. PLEASE CONTACT OUR OFFICE FOR INSPECTIONS. YOU WILL BE REQUIRED TO SUPPLY BUILDING AND/OR PLUMBING PERMIT NUMBERS. THE PHONE NUMBERS ARE ON THE FRONT OF THIS APPLICATION. INSPECTORS CAN BE REACHED THERE BETWEEN 8 AND 9 A.M. FOR CODE RELATED QUESTIONS.
