<p>JUSTICE OF SUPREME COURT 8 Year Term <i>Vote for not more than 1</i></p> <p>Doug Dern <input type="radio"/></p> <p>Frank Szymanski <input type="radio"/></p> <p>David Viviano <input type="radio"/> <small>Justice of Supreme Court</small></p>	<p>PROPOSITION FOR CONSTRUCTION AND EQUIPPING OF AN EXPANSION TO THE LIBRARY MILLAGE</p> <p>This proposal is for a new millage and will permit the County to levy up to 37.5/100 of one mill (\$0.375 per \$1,000.00 of taxable valuation) to provide funds for the construction and equipping of an expansion to the Otsego County Library facility.</p> <p>Shall the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution on the amount of ad valorem taxes which may be levied by the County of Otsego, State of Michigan, against taxable property in the County be increased by up to 37.5/100 of one mill (\$0.375 per \$1,000 of taxable value) on the taxable value of such property for a period of six (6) years, 2016 through 2021, inclusive, for the purpose of providing funds for the construction and equipping of an expansion to the Otsego County Library facility in Gaylord, and shall the Otsego County Board of Commissioners be authorized to levy such millage for these purposes?
