**Otsego County Parks and Recreation Commission
Special Meeting June 26th, 2023
Approved Minutes**

Call to order at 6:00pm by president Bonny Miller at the Otsego County Community Center.

Members Present: Bonny Miller, Jack Korte, Troy Huff, Randy Stults, and Justin Wing.

Members Absent: Trevor Burroughs, Scott Courterier and Judi Jarecki.

Public Comment: Gary Rider from the Otsego Pickleball Association discussed the popularity of pickleball in the area. Gary Rider informed the members that he painted lines for 4 additional courts on the tennis court at the Community Center.

Old Business:

1. **Community Center Roof Repairs:** Jacob Brown met with Justin Wing and Scott Courterier to look at repairs needed. Justin Wing prepared a request for proposals and asked for a general contractor be hired to coordinate the repairs. Jack Korte thanked Justin Wing for preparing the proposal. A motion was made by Randy Stults and seconded by Troy Huff to put out requests for invitation for bids for the Community Center building rehabilitation. Motion carried.
2. **Basketball Camp Event Form:** Jacob Brown presented a copy of the insurance certificate. Randy Stults identified some updates required for the paperwork. A motion was made by Justin Wing and seconded by Jack Korte to approve the rental request contingent upon having the proper paperwork which names the entity. Randy Stults opposed this motion. Motion carried.
3. **Lacrosse Camp Event Form:** Jacob Brown said the Petoskey Lacrosse Group requested using Libke Fields once a month through the end of the year for Lacrosse camps. A motion was made by Justin Wing and seconded by Troy Huff to approve the paperwork subject to verification that the Petoskey Lacrosse Group is a member of USA Lacrosse. Motion carried.

Commissioner Comments: Bonny Miller said she will not be at the next meeting.

Jacob Brown said the new utility vehicle was presented to the Budget and Finance Committee. Jacob Brown presented some options to lower the cost such as gasoline instead of diesel.
