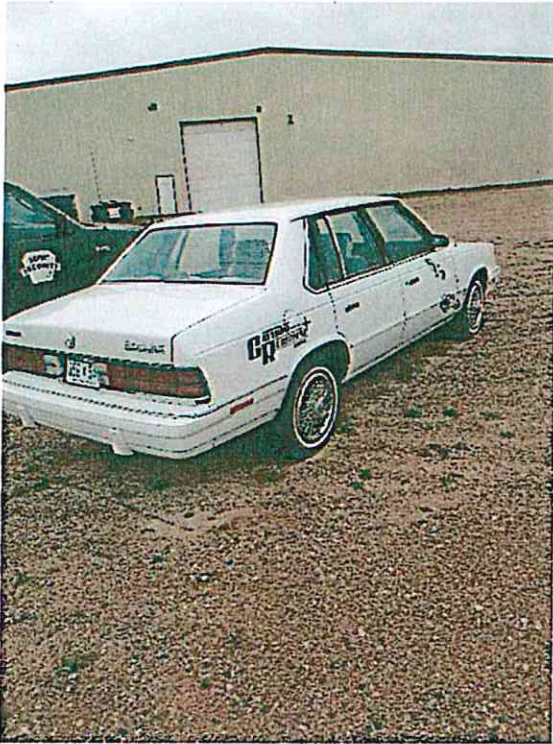
Otsego County will accept bids and sell the equipment in an **"as is" used condition only.**
