Costs for New Cabins

Cabins- \$20,900

Moving existing cabins- \$250

Excavating/site prep/concrete (for all four cabins)- \$10,800

Electric for all four cabins (including ceiling fans in new cabins- \$4,135

Furniture for new cabins- \$8800

Flooring- \$670

Interior Doors- \$200

Miscellaneous- \$950

Total Cost- \$46,705

Last year our two existing cabins sold 184 days at a cost of \$55/night. If we charge \$85/night for the larger cabins it would take 550 days to pay for themselves. If we were able to maintain the rate at which the existing cabins were rented in 2016 it would take approximately 3 years for a full pay off.
